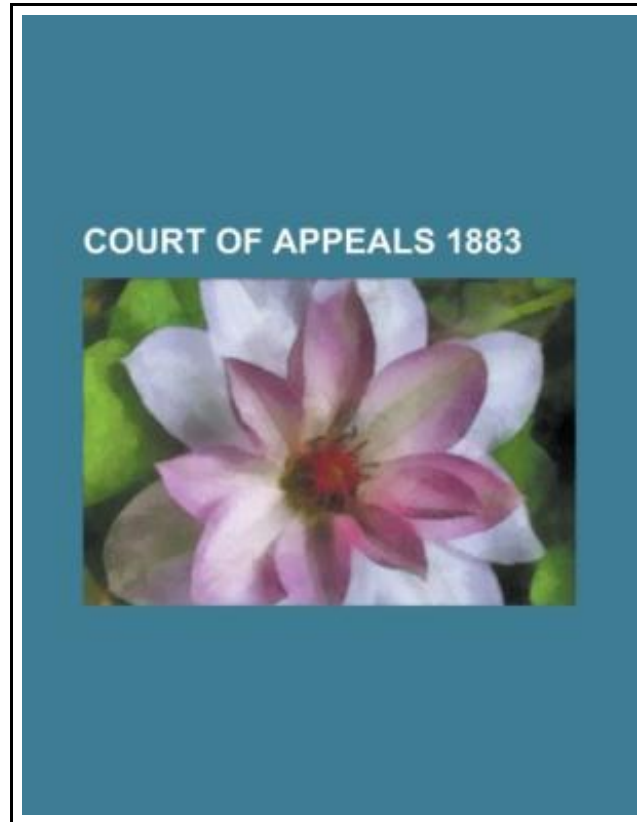

For section 10 provides that each town shall thereafter be charged with the share of such debts according to such apportionment. It seems, therefore, to us, that this apportionment ought to be made, and that it is not reasonable to enforce the debt against that part of the divided town which retains the old name.
